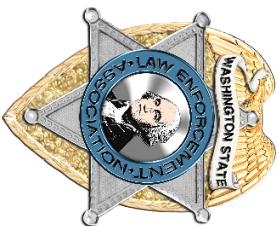

CONTEST RULES

- 1 This contest is open to any student who is enrolled in a Washington eighth-grade class during the 2017-2018 school year.
- 2 All essays must address the theme: *Why I will say NO to Alcohol & Drugs*
- 3 The essay must be less than 750 words. Any entry received with more than 750 words will be disqualified. The essays may be either typewritten or legibly handwritten.
- 4 **All entries must be submitted with an entry form and must be signed by the student. The form is on the back of this pamphlet and can be photocopied by the school.**
- 5 For each school participating in the contest, the WSLEA requests that the school principal or class instructor select and **submit only the three best essays from all eighth-grade students who have submitted their work.** This will assist the Association judges in choosing the overall winner from a smaller number of prejudged finalists.
- 6 Please note the criteria the Association judges will use to select winners is based primarily on the **essay content and message** with only minor consideration for spelling and punctuation.
- 7 A statement from the parent/guardian, teacher or school principal must accompany each entry attesting that to the best of his/her knowledge, the essay was written unaided (except for appropriate research and reference). A single statement from a teacher or principal is sufficient for a group of entries submitted from the same class or school.
- 8 All winners will be contacted through their schools, by phone or by mail.
- 9 **ALL ENTRIES MUST BE POSTMARKED NO LATER THAN FEBRUARY 28, 2018.**
- 10 Entries become the property of the WSLEA. No entries will be returned, and we are not liable for any lost or missing entries. The WSLEA reserves the right to reproduce any entries for publication or publicity and to publicize the names of the winners.
